ORDER

The proposals for amending certain clauses of Academic regulations for B.Sc. M.Sc. (Integrated) Programme recommended by the 56th meeting of Board of Studies (Ag.) held on 27/06/2015 was placed before the 125th meeting of Academic Council meeting held on 10/07/2015. After a detailed discussion the council has approved three recommendations as such and the last one approved with modifications.

In consonance with the decision of the 125th meeting of the Academic Council held on 10/07/2015, sanction is accorded to amend the following clauses of regulations for the B.Sc. M.Sc. (Integrated) Programme.

- (1) The title of the course modified as B.Sc. M.Sc. (integrated) course.
- (2) Clause No.17 – credit load in a semester.

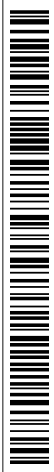
The credit load in a semester for B.Sc. M.Sc. (Integrated) will be modified from 27 credits into 32 credits which included regular, repeat and re-examination courses but exclude from training/field training/Industrial experience/Project work/Work experience/Physical education.

- (3) Clause No.19 – Tuition and other fees.

The Tuition fees and other fees for students registering for semesters 11 (eleven) and beyond will be fixed as Rs.10,000/- fees semester plus any other fees prescribed by the University. However if a student has to register any repeat course along with other courses during semester 11 (eleven) and beyond he/she has to pay the entire tuition fees of Rs.30,000/- or Rs.50,000/- per semester as the case may be plus any other fees prescribed by the University.

- (4) Clause No. 38 – Final Viva-voce examination.

The Board of examiners conducting the final Viva-voce examination shall consist of the Major advisor, members of the Advisory Committee and External Examiner. This modification will be made applicable to integrated programme in climate change adaptation for admissions of 2010 batch onwards and to integrated programme in Biotechnology for admissions of 2012 batch onwards.
